**POLICE INCIDENT – Lancaster County, 7/29/16** – A local TV station reported that police in Columbia Borough responded to reports of a suspect firing shots at police vehicles in the area of 600 to 900 blocks of Locust Street and Chestnut Streets in Columbia Borough. Columbia Police requested residents to shelter in place until the situation was resolved. Two suspects were placed into custody mid-morning yesterday.

**VEHICLE CRASH INTO HOSPITAL – Philadelphia County, 7/29/16** - A pick-up truck lost control and crashed into the lobby of the Magee Rehabilitation Hospital, Race Street, in the City of Philadelphia. There were four injuries to hospital employees; one of which was serious. All of the victims were transported to Hahnemann Hospital. There was no structural damage to the facility.

### **DISASTER DECLARATIONS:**

7/25/2016 – The Mayor of Dunmore Borough issued a Declaration of Disaster Emergency for the borough due to severe weather.

7/19/2016 – The U.S. Small Business Administration issued a SBA disaster declaration for Fayette, Greene, Somerset, Washington and Westmoreland counties for damages during the flooding event on June 17, 2016. The effective date is 7/19/16 and termination date for applications is 9/19/16. Economic Injury Disaster Loan (EIDL) application termination date is 4/19/17.

6/2/2016 – The Commissioners of Clearfield County have issued Declarations of Disaster Emergencies for Lawrence Township, Clearfield Borough, and Clearfield County due to severe weather and flooding.

3/23/16 - The U.S. Department of Homeland Security's Federal Emergency Management Agency announced that federal disaster aid has been made available to the Commonwealth of Pennsylvania to supplement commonwealth and local recovery efforts in the area affected by the severe winter storm which occurred January 22-23, 2016. The designation is FEMA-4267-DR.
