DISASTER DECLARATIONS:

8/17/16 – The Borough Council Members of Donora Borough issued a Declaration of Disaster for the borough, due to severe weather.

8/10/2016 – The Borough Council Members of Albion Borough issued a Declaration of Disaster Emergency for the borough, due to a drought/water emergency.

7/25/2016 – The Mayor of Dunmore Borough issued a Declaration of Disaster Emergency for the borough, due to severe weather.

7/19/2016 – The U.S. Small Business Administration issued a SBA disaster declaration for Fayette, Greene, Somerset, Washington and Westmoreland counties for damages during the flooding event on June 17, 2016. The effective date is 7/19/16 and termination date for applications is 9/19/16. Economic Injury Disaster Loan (EIDL) application termination date is 4/19/17.

3/23/16 - The U.S. Department of Homeland Security's Federal Emergency Management Agency announced that federal disaster aid has been made available to the Commonwealth of Pennsylvania to supplement commonwealth and local recovery efforts in the area affected by the severe winter storm which occurred January 22-23, 2016. The designation is FEMA-4267-DR.

24-hour Projected Weather Statewide:

National Weather Service, 0557 hours, 08/28/16:

A warm front over western Pennsylvania will push east into the region this morning, followed by the passage of a weak cold front tonight and Monday morning. This pair of frontal systems will bring scattered showers and thunderstorms to mainly the northwest half of the state this afternoon and tonight.

High temperatures today will vary between 85 and 90 degrees, with lows tonight in the lower 60s across the north and mid to upper 60s elsewhere.

Another period of warmer than normal and mainly dry weather will follow for Monday into early Wednesday. A stronger cold front will move southeast across the Commonwealth Wednesday followed by a refreshingly cooler air mass with low humidity Thursday through Saturday.
